Councilmember Abram noted that she would like to see the City focus more funding towards traffic enforcement. She would like the City to consider using ARPA funds for infrastructure projects for public safety, specifically noting future planning for relocation of a fire station. She requested that the City hire an asset firm to assist with investments.

Vice Mayor Franco requested that the City continue to focus on public safety and roads.

Councilmember Bixel agreed with the aforementioned focuses, noting that the firehouse on Walnut road needs improvements sooner rather than later. He added in regards to public safety, a focus on traffic enforcement, possibly the implementation on a decoy.

Mayor Bublak stated her focus would be recruiting and retaining staff, improving roads, and economic development.
